The CNM Office leads the strategic direction of the nursing and midwifery professions through engagement across the public and private sector and the health and education providers to build guality and effective delivery of nursing and midwifery services in Western Australia with a safe, effective workforce.

### Strategy

Nursing and Midwifery Strategic Direction and Work Plan. System nursing and midwifery leadership is provided via the WA Health Nursing and Midwifery Advisory Council (WAHNMAC). Membership comprises all Area Executive Directors of Nursing and Midwifery. WAHNMAC meet monthly with the purpose to support implementation of the strategic direction.
