National COVID-19 Aboriginal epidemiological profile

There has been a significant decrease in the rate of completion of Aboriginal identification among notified COVID-19 positive cases recorded in the National Notifiable Disease Surveillance System (NNDSS). This has likely resulted in the under-reporting of positive or confirmed cases among Aboriginal Australians in the NNDSS.

Below is a summary of the epidemiological profile of COVID-19 among Aboriginal Australians, as at **16 January 2022**. **New data will be provided in the next update.**

Please note, the data is preliminary and subject to change.

January 2020 to January 2022:

- Since the start of the pandemic to **16 January 2022**, around **2.3%** (**29,328** cases) of the **1,254,909** positive cases notified in the Australian National Notifiable Disease Surveillance System (NNDSS) were identified as Aboriginal people. There was more than a threefold increase in reported cases from **5 December 2021** (**8,955** cases).
- Over the last six months (since 16 June 2021), COVID-19 cases among Aboriginal Australians (relating to outbreaks in NSW, ACT, Vic, QLD, SA, Tas and NT) have grown over **191** times since **16 June 2021**, increasing from **153** confirmed cases to **29,328** cases at **16 January 2022**.
- Of the all positive cases among Aboriginal Australians reported in NNDSS, around **60.5%** (**17,742** cases) were from NSW, **18.4%** (**5,401**) from QLD, **14.2%** (**4,170**) from Vic, **3.4%** (**990**) from SA, **1.9%** (**543**) from ACT, **0.9%** (**270**) from NT, **0.7%** (**208**) from Tas and **0.01%** (**4** cases) from WA.
- Around **99%** (**29,012**) of confirmed cases among Aboriginal people acquired their infection locally.
- Of the total **29,012** locally acquired cases, around **59%** were in major cities, **25%** were in inner regional areas, **13%** were in outer regional areas and **3%** were in remote areas.
- The highest proportion of cases among Aboriginal people was in the 18 to 29 years age group (around **30%**).
- Around a quarter (**24.8%**) of reported COVID-19 cases among Aboriginal people in the NNDSS were children aged 0 to 11 years, while the proportion of confirmed cases among Aboriginal people aged 50 years and older was **10.3%**.

- It is estimated that only around **2%** of confirmed COVID-19 cases among Aboriginal people were vaccinated with their third dose (booster), **65%** with their second dose, **1%** with their first dose, **25%** with no vaccination and **8%** have an unknown record of vaccination against COVID-19.
- About **8%** of Aboriginal positive cases required hospital care (including ICU admissions) with around a **0.1%** mortality rate (**31** deaths notified in total).
- NSW had the highest number of deaths (**84%** or **26** deaths), Vic had **3** deaths (**10%**), QLD and NT each had one death (**6%**). These deaths accounted for **1.2%** of all COVID-19 deaths.
- The completeness of Aboriginal status identification fields in the NNDSS dropped significantly to **51%** in this reporting period, down from **81%** in the previous reporting period.

Vaccination status:

As at **22 February 2022:**

- In Western Australia, around **75%** of Aboriginal people aged **12 years and over** have been vaccinated against COVID-19 with their first dose, and **63%** have received their second dose. This is compared to **76%** and **66%** of Aboriginal Western Australians aged **16 years and over** who are vaccinated with their first dose and second dose, respectively.
 - Around **68%** of Aboriginal Western Australians aged **16 years and over** living in Perth metropolitan areas have received 2 doses of COVID-19 vaccine, compared to **58%** for those living in regional areas.
 - In the Perth metropolitan area, Aboriginal Western Australians aged **16 years and over** living in the east metropolitan area have the highest percentage of people who have had 2 doses (**73%**) while the south metropolitan area has the lowest percentage (**62%**).
 - In regional areas, the South West region has the highest proportion of Aboriginal people aged **16 years and over** who are vaccinated with two doses (**71%**), while the Goldfields (**42%**) and Pilbara (**53%**) have the lowest percentage of people who have had two doses of vaccine against COVID-19.
- Around **22%** of Aboriginal Western Australians aged **16 years and over** have received a booster dose of COVID-19 vaccination (**25%** for Perth metropolitan areas and **18%** for regional areas).
- Across Australia, around **83%** of Aboriginal people aged **16 years and over** have been vaccinated with their first dose, while **78%** have been vaccinated with their second dose.
- ACT has the highest percentage of Aboriginal people aged **16 years and over** who have received their first and second doses (**91%** and **89%**, respectively). They are followed by Victoria (**89%** and **87%**), Northern Territory (**89%** and **82%**), Tasmania (**88%** and **84%**), New South Wales (**87%** and **84%**), Queensland (**80%** and **75%**), and South Australia (**78%** and **71%**).

The Australian Government provides weekly reports, listing the percentage of people aged 15 and over who have self-identified as Indigenous, and who have been vaccinated against COVID-19. This information is provided by statistical area 4 (SA4) and is further broken down by geographic regions and number of doses. These reports can be found [here](#).

Living with COVID and latest updates

Bidyadanga and Beagle Bay cleared of COVID-19: based on follow up pathology testing

The WA Department of Health can confirm that follow up pathology testing carried out in the Bidyadanga and Beagle Bay communities has given an 'all clear' COVID-19 result.

Initial tests in the communities (carried out on a GeneXpert rapid PCR machine) indicated positive results however, secondary PCR testing showed that some community members have respiratory virus infections – such as the flu and rhinovirus – but not the more virulent COVID-19.

The Kimberley Aboriginal Medical Service (KAMS) provided an immediate response, working closely with the Bidyadanga and Beagle Bay communities, WA Country Health Service and the Department of Health to ensure the communities were protected.

COVID is in the WA community

There is now community transmission of COVID-19 throughout WA and people should not rely only on the exposure sites listed on the HealthyWA website to consider getting tested.

Anyone experiencing COVID-19 symptoms should get tested immediately and isolate until they receive a negative result, unless directly advised otherwise by the Department of Health.

New drive to increase Aboriginal vaccinations

A new vaccination campaign for Aboriginal people, '*Keeping Culture Safe and Strong - Get the needle now*' has deployed teams of metropolitan vaccinators and support staff into regions with low vaccination rates.

Like a fly-in-fly-out model, Department of Health staff will support vaccination and administrative teams from the WA Country Health Service and Aboriginal Community Controlled Health Organisations in the Kimberley, Pilbara, Mid-West and Goldfields-Esperance regions over the next six weeks. Aboriginal Medical Services will also play an important role, engaging and vaccinating local people.

Outbreaks of the Omicron variant across Western Australia have highlighted the importance of the booster dose, as well as the primary course (two doses) of COVID-19 vaccines.

Free rapid antigen tests for Western Australians

Every household in Western Australia can [register to receive 5 free COVID-19 rapid antigen tests](#) (RATs). You can register [online](#) or by calling 13COVID (13 268 43).

As part of the program, a member of each household can register for the 5 free RATs and have the tests delivered to their home address.

10 additional free RATs are available to concession card holders through the Australian Government and can be collected from participating pharmacies. See the [announcement](#) for more information.

People who have self-administered a RAT for COVID-19 and tested positive must register their result [online \(external link\)](#) with the WA Department of Health.

People who do not have access to the online registration system must still report their positive test result by calling 13 COVID (13 268 43).

TTIQ (Test, Trace, Isolate and Quarantine) Plan

As WA transitions to living with COVID-19, and caseloads are higher in the community – businesses, facilities and service providers will have to play a more active role in managing COVID-19 communications in their workplaces.

The [TTIQ Plan](#) webpage provides guidance and resources for businesses, facilities, and service providers to assist with the transition. These resources provide information on how to notify close contacts in the workplace of a COVID-19 positive case, and the testing, contact tracing, isolation and quarantine (TTIQ) requirements in different settings – including businesses, schools and aged care.

Community healthcare practice guidelines

The COVID-19 Guidelines for Healthcare Practices in the Community in a High and Very High Caseload Environment will assist healthcare practices in assessing the risk following a COVID-19 exposure. They are considered different to general workplace settings due to the potential susceptibility of patients and the duty of care related to providing health services. The guidelines will ensure that healthcare practices in the community can risk-assess COVID-19 exposure and ensure continuity of critical services, particularly in remote and rural WA, and that healthcare practitioners are better positioned to support patients in their ongoing health needs.

WA COVID Care at Home program

The [WA COVID Care at Home program](#) has been launched to provide home monitoring care for COVID-19 positive people who have risk factors which put them at greater risk of requiring hospitalisation. It is a free service; however registration is required to determine whether the case

would benefit from additional monitoring through COVID Care at Home. People can register on the [HealthyWA website](#) or call 13COVID if they need assistance registering.

New information on HealthyWA

The WA Department of Health continues to develop resources and update information to ensure the WA public can access health advice relevant to the current COVID-19 situation in WA.

The [HealthyWA website](#) has useful advice on [managing COVID-19 at home](#) and in the community, which will continue to be updated as the situation evolves. The WA COVID Care at Home [program](#) and positive rapid antigen test result online registration [portal](#) are also on HealthyWA - check these pages regularly for updates.

The current COVID-19 situation in WA is different to what is occurring in other states. Business, industry and other agencies developing their own COVID-19 resources are strongly encouraged to source information from [HealthyWA](#), the [Department of Health](#) and [WA.gov.au](#) websites, to ensure messaging is consistent with current WA advice.

Video resource - COVID-19 vaccine is now available for kids aged 5-11 years

The Australian Government has developed an animation for Aboriginal and Torres Strait Islander people, explaining that kids aged 5 to 11 years are now eligible for the COVID-19 vaccine. Watch the video on www.health.gov.au.

Video resource - COVID-19 infects young and healthy people too.

Last year the Delta variant of COVID-19 infected more than 2,000 Aboriginal and Torres Strait Islander people aged 20 years and under in eight short weeks. Omicron is more than doubling this rate of infection. More than 23,000 COVID cases have been notified among Aboriginal and Torres Strait Islander people in January 2022.

“Stay COVID safe” resources for remote Aboriginal communities

A series of posters have been developed for use in remote Aboriginal communities, encouraging community members to get vaccinated and stay COVID safe.

COVID-19 vaccination program

Vaccination is the best way to protect our community from COVID-19. **Everyone aged 5 years and older is now eligible to receive a COVID-19 vaccination.** People can book an appointment to receive the COVID-19 vaccine that is appropriate for them at:

- their local Aboriginal Medical Service (AMS), or
- at a state-run COVID-19 vaccination community clinic, or

- at a regional public hospital-based vaccination clinic.

Alternatively, participating AMS or GP clinics can be found by using the [Vaccine Eligibility Checker](#).

Pregnant and breastfeeding women, and those planning to become pregnant are now recommended to have the Pfizer vaccine. Community clinics

Please check the [community vaccination clinic list](#) for further information and opening times. To avoid extended queues, people are encouraged to make a booking at [VaccinateWA](#) or 13COVID, as people with bookings will be prioritised.

The Comirnaty (Pfizer) COVID-19 vaccine is now being rolled out to, and administered by, GPs in WA. Approved pharmacies can also now administer the Spikevax (Moderna) and AstraZeneca COVID-19 vaccines for eligible populations. Participating GPs and pharmacies can be found by using the [COVID-19 Vaccine Clinic Finder](#).

Alternatively, you can contact your local AMS or General Practice to find out if they are offering COVID vaccinations. Anyone having difficulties booking on VaccinateWA can call 13 COVID (1326843) for assistance.

Door to door vaccination success

Indigo Junction: Congratulations to Indigo Junction, a not-for-profit organisation providing homelessness services, who have been conducting door-to-door COVID-19 vaccination services. More than 500 people who may not have had access to vaccinations, have now been protected with their first, second, or third dose of a COVID-19 vaccine as a result of this program.

Mobile Vaccination Program

The State's COVID-19 vaccination program offers an in-reach mobile vaccination service. This service makes access to vaccination easier for people who are having difficulty attending other vaccination service providers.

The mobile vaccination program is a cross government/community initiative that works state-wide with Aboriginal leaders and agencies in regions where rate of vaccination uptake is low.

Recently, the COVID-19 Vaccination Aboriginal Health Team partnered with the Aboriginal Health Team in Community Health, Child and Adolescent Health Services (CAHS) to vaccinate a group of mums who hadn't been previously vaccinated. The mums were not against vaccination; they didn't know how to book an appointment or where to go to get vaccinated. The team organised a suitable venue for the mums to meet and the mobile vaccination team was able to get everyone vaccinated on the day.

Aboriginal health teams and community health teams within Health Service Providers (HSPs), sector and not-for-profit organisations can request this mobile vaccination service to assist people in the community getting vaccinated. Priority COVID-19 health messages for Aboriginal people

Aboriginal health professionals and sector representatives are encouraged to promote and reinforce the following key messages to Aboriginal clients and community. Remember to:

- get your COVID vaccine as soon as possible
- get your second dose of COVID vaccine as soon as you are due
- get your booster dose as soon as you are due
- physical distance where possible
- practise good hand hygiene and cough etiquette
- stay at home if unwell and rest to stay strong
- if unwell with flu-like symptoms, get tested (make sure to quarantine until you receive your test result)
- make sure your family gets the flu vaccine
- keep attending your regular health checks, especially for chronic illnesses
- download and use the free [ServiceWA](#) or [SafeWA app](#) for your phone
- look after your mental health, and social and emotional wellbeing during this time

Statewide Aboriginal resources

The Department of Health has developed a suite of statewide resources tailored for Aboriginal people. The aim of providing culturally appropriate communications is to increase awareness and reduce anxiety and fear in our communities. We encourage Aboriginal health professionals to demonstrate leadership when working with the Aboriginal community by:

- being “on message”
- reinforcing and encouraging people to ‘stay vigilant’ and ‘don’t get complacent’
- using positive, strengths-based messaging and language
- providing consistent, accurate and timely communication, based on the official public health messages and health information issued by the Chief Health Officer from the Department of Health.
