In this submission, I argue, Department of Health, along with Department of Education, can become a very effective way in communicating 'climate change' to various communities. Take a compulsory vaccination program for an example. This program undoubtedly has effectively communicate to families the importance in vaccinating their children, regardless their background.

Taking recent examples from 'school strike for climate' movement, it has been argued that it has effectively change their sceptical parents regarding climate change issues (<https://www.scientificamerican.com/article/children-change-their-parents-minds-about-climate-change/>). Therefore, I argue, in this short submission, Department of Health (along with Department of Education) can become instrumental in implementing actions in communities in order to inspire systemic changes in communities in response to climate crisis.

As a parent of two young boys myself, I have never heard my children, teachers, or fellow parents discussing anything related to climate change (let alone climate crisis). This highlights that general communities in Western Australia, I believe, still have not taken the gravity of the problem seriously. Those who do take the issue seriously, have nobody to discuss or share their frustration (apart from the alienating social media). I believe this can lead to other mental health issues, which I wish to write further, but not the subject of this particular submission.

What is exactly Department of Health's role to lead in this particular matter? I will not pretend I'm the expert of the matter, but I do hope it will lead the implementation of compulsory education in WA schools regarding climate change and its impacts. Department of Health can lead the discussion, along with Department of Education to introduce the curriculum to WA schools.

One of the low hanging fruit that I can immediately see is taking more seriously the

implementation of 'ride or walk to school' day. This can be a gateway for further education about Australia's transport emission, and the requirement of reducing it. A day for awareness is not enough, hence, I argue the requirement of constant material (i.e. education) around carbon emission (not just transport emission). This is a huge and complicated topic, hence, I'm not going to pretend a single submission will be enough.

In short, if the adults unwilling to do it, let's hand over to those who can do and inspire us (adults) to do better.
